SUBJECT: Health, Dental and Life Insurance Renewal

On July 1, 2016, the Village joined the Intergovernmental Personnel Benefit Cooperative (IPBC) for its health, dental and life insurance policies. These policies are scheduled to renew on July 1, 2019.

Itasca's current health insurance carrier is Blue Cross and Blue Shield of Illinois and it currently offers a PPO plan and an HMO plan. The PPO plan renewal rate for the 2019-2020 plan year will increase by 0.9%, while the HMO plan will increase by 3.4% for the same period. The carrier for the dental insurance plan is Metlife and the premium will be 6.4% more effective July 1st, 2019. For historic comparison purposes, the average premium increase in the last three years prior to joining IPBC was 11.25%. We achieved a 10.5% reduction in premium in 2016, the year we moved to IPBC and the average premium increase in the 3 years after that was only 2.87%. Additionally, the premium for the current 2019-2020 renewal is lower than the premium we paid 4 years ago, in the 2015-2016 plan year. As such, we continue to reap benefits from joining IPBC.

Life insurance is offered through Standard Life. Staff proposes transitioning from a flat rate life insurance policy, which offered a standard \$50,000 coverage for each full time employee to a 1x their salary structure, which is more commensurate with the market benefit structure. The change will cost the Village an additional \$198 per month.

Staff is recommending the Board renew the Village's health, dental and life insurance policies with IPBC effective July 1st, 2019.

**A RESOLUTION AUTHORIZING APPROVAL OF
HEALTH, DENTAL AND LIFE INSURANCE RENEWAL**

WHEREAS, on July 1, 2016, the Village of Itasca joined the Intergovernmental Personnel Benefit Cooperative (IPBC) for its health, dental and life insurance policies and these policies are scheduled to renew on July 1, 2019; and

WHEREAS, the Village wishes to accept and approve the health and dental renewal rates for the 2019 – 2020 plan year as negotiated by IPBC; and

WHEREAS, the Village wishes to transition from a flat rate \$50,000 life insurance policy to a 1-time the employee’s salary structure policy offered through Standard Life and negotiated by IPBC.

NOW, THEREFORE, BE IT RESOLVED by the President and the Board of Trustees of the Village of Itasca, DuPage County, Illinois, as follows:

SECTION ONE: The corporate authorities of the Village of Itasca hereby approve and accept the health and dental insurance policies renewal negotiated by IPBC for the 2019 – 2020 plan year and transition to a 1-time the employee’s salary structure policy offered through Standard Life and negotiated by IPBC.

SECTION TWO: The Village President, or his designee, is hereby authorized to sign and execute, on behalf of the Village of Itasca, any necessary documents to formalize the acceptance of the health, dental and life insurance policies renewal.

SECTION THREE: SEVERABILITY. If any section, paragraph or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this Resolution.

SECTION FOUR: REPEAL OF PRIOR RESOLUTIONS. All prior Resolutions and Ordinances in conflict or inconsistent herewith are hereby expressly repealed only to the extent of such conflict or inconsistency.

SECTION FIVE: EFFECTIVE DATE. This Resolution shall be in effect immediately from and after its passage and approval.
