**1. Call to Order**

The May 21, 2019 regular meeting of the Village Board of Trustees was called to order at 7:12 p.m. by Mayor Pruyn.

**4A. Village Board of Trustees Meeting Minutes – May 7, 2019**

**5A. Presentation – Republic Services**

Republic Services Manager of Municipal Sales Jacob Diliberto presented an overview of Republic Services and their recycling program. With China no longer purchasing recycling products, the cost of recycling product is now more than putting products into a landfill. For 2019, Republic Services is focusing on educating consumers to recycle clean, dry, and empty cardboard boxes, paper, metal, and plastic items. The Village will be promoting this focus through direct mailings and through its website, as well as allowing Republic Services to setup promotional booths at our summer fests.

**6. President Comments**

Mayor Pruyn reported Illinois Senate Bill 1217 allowing DuPage County municipalities the ability to spend 25% of hotel sales tax on items other than tourism passed by the Illinois Senate and House and is going to Governor Pritzker for signature.

Residents including the Boy Scouts and Adventure Princess picked up garbage and cleared log jams in Spring Brook between Valley and Irving Park Roads. Trustee Latoria recommended the youth groups be recognized at a future meeting.

Mayor Pruyn reported receiving an email requesting the Village ask the Itasca Park District to update the playground at Raymond Benson Primary School.


