

RESOLUTION NO. 1316-21

A RESOLUTION AUTHORIZING THE EXECUTION OF A MEMORANDUM OF AGREEMENT BETWEEN THE VILLAGE OF ITASCA AND THE INTERNATIONAL UNION OF OPERATING ENGINEERS, LOCAL 150 (PUBLIC EMPLOYEES DIVISION)

WHEREAS, pursuant to the Illinois Municipal Code, 65 ILCS 5/11-76-1 *et seq.*, the Village of Itasca is authorized to enter into collective bargaining agreements;

WHEREAS, the Village of Itasca (“Village”) and the International Union of Operating Engineers, Local 150 (“Union”) are parties to a collective bargaining agreement covering certain Public Works and Administrative employees with a term effective May 1, 2018, through April 30, 2021;

WHEREAS, the parties have negotiated a one-year extension of the contract during the financial crisis caused by the coronavirus pandemic; and,

WHEREAS, the Board of Trustees deems it to be in the best interests of the Village to enter into a Memorandum of Agreement to extend for one additional year the collective bargaining agreement with the International Union of Operating Engineers, Local 150 (Public Employees Division) bargaining unit.

NOW, THEREFORE, be it resolved by the Board of Trustees of the Village of Itasca as follows:

SECTION ONE: The President and the Village Clerk of the Village of Itasca are hereby authorized to execute a Memorandum of Agreement to extend for one additional year the 2018-2021 collective bargaining agreement substantially in the form of the Agreement attached hereto as Exhibit A and made a part hereof.

SECTION TWO: This Resolution shall be in full force and effect upon its passage and approval as required by law.

SECTION THREE: This Resolution supersedes any resolutions or motions, or parts of resolutions or motions, in conflict with any part herein, and any such resolutions or motions, or parts thereof, are hereby repealed to the extent of any conflict.

SECTION FOUR: If any section, paragraph, or provision of this Resolution shall be held invalid or unenforceable for any reason, such invalidity or unenforceability shall not affect any of the remaining provisions of this Resolution.

**MEMORANDUM OF AGREEMENT
INTERNATIONAL UNION OF OPERATING ENGINEERS, LOCAL 150 &
VILLAGE OF ITASCA**

WHEREAS, the Village of Itasca (“Village”) and the International Union of Operating Engineers, Local 150 (“Union”) are parties to a collective bargaining agreement covering certain Public Works and Administrative employees with a term effective May 1, 2018 through April 30, 2021 (“CBA”);

WHEREAS, the parties have negotiated a one-year roll-over of the contract during the financial crisis caused by the coronavirus pandemic;

WHEREAS, the parties modified the agreement to extend it for an additional one year in exchange for the other considerations referenced herein;

NOW, THEREFORE, the parties agree to revise the CBA as follows:

1. Article XXVII Termination:


The May 1, 2017 through April 30, 2021 CBA will be extended by one (1) additional year and shall now expire on April 20, 2022.
