

## RESOLUTION NO. 1246-20

### A RESOLUTION AUTHORIZING A THIRD ITASCA BUCKS PROGRAM EXTENSION TO SUPPORT LOCAL RESTAURANTS AND RESIDENTS

WHEREAS, the Village of Itasca (herein "Village") adopted a program to provide direct financial assistance to Itasca restaurants, breweries, and residents in response to the COVID-19 crisis through the "Itasca Bucks" program wherein each resident is provided with \$50.00 in vouchers which can be used at participating restaurants and breweries when they spend a minimum at the participating business through July 31, 2020, in Resolution No. 1206-20, and extended the program through December 31, 2020, in Resolution No. 1221-20; and

WHEREAS, Itasca Bucks continues to successfully generate business at participating local restaurants and breweries; and

WHEREAS, the Village wishes to extend the program through April 30, 2021, issue new vouchers to residents and businesses to use; and

WHEREAS, Village costs associated with Itasca Bucks have not and are not expected to exceed the \$215,624.80 authorized for the program in Resolution No. 1206-20.

NOW, THEREFORE, BE IT RESOLVED by the President and the Board of Trustees of the Village of Itasca, DuPage County, Illinois, as follows:

SECTION ONE: The corporate authorities of the Village of Itasca hereby authorize an extension of the Itasca Bucks program to provide each resident and business with \$50.00 in vouchers to spend at participating restaurants and breweries located in the Village of Itasca, when a minimum amount is spent. Participating restaurants and breweries may seek reimbursement for redeemed vouchers from the Village.

SECTION TWO: The Village President or his designees is hereby authorized to sign and execute any documents necessary to create and maintain the Itasca Bucks program on behalf of the Village of Itasca.

SECTION THREE: SEVERABILITY. If any section, paragraph, or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph, or provision shall not affect any of the remaining provisions of this Resolution.

SECTION FOUR: REPEAL OF PRIOR RESOLUTIONS. All prior Resolutions and Ordinances in conflict or inconsistent herewith are hereby expressly repealed only to the extent of such conflict or inconsistency.

SECTION FIVE: EFFECTIVE DATE. This Resolution shall be in effect immediately from and after its passage and approval.


